ORDER

The State of Assam is facing severe calamities in the ongoing wave of South West Monsoon (2019). Various villages in the districts of Assam are severely affected with the excessive rainfall in the State and neighbouring States, causing flooding, landslides and consequent disasters like river erosion which has caused disruption to normal life.

As per the Government Order read as above, the districts of Dhemaji, Lakhimpur, Biswanath, Sonitpur, Darrang, Nalbari, Baksa, Barpeta, Chirang, Dhubri, South Salmara, Goalpara, Kamrup, Kamrup (M), Morigaon, Hojai, Majuli, Dibrugarh and Hailakandi are declared as fully affected by this disaster covering all the Revenue Circles and the remaining districts of Assam i.e Udalguri, Bongaigaon, Kokrajhar, Nagaon, Golaghat, Jorhat, Sivasagar, Tinsukia, Cachar, Karimganj, West KarbiAnglong, KarbiAnglong, Dima Hasao (Landslide)are declared as partially affected by this disaster as per Government Order read as above in the ongoing wave of South West Monsoon (2019).

In addition to this, the list of various Villages, Revenue Circles and Districts notified as flood/landslide affected in the State of Assam during the ongoing Flood 2019 is attached as Annexure to this Government Order. A formal gazette notification will be issued shortly.
