Minutes of the State Level Empowered Committee Meeting on CORONAVIRUS (COVID-19) held on 4th May, 2024 (Time: 11.30 AM) at Chief Secretary Conference Hall, Dispur

The list of officers present in the meeting is given at Annexure "A"

The meeting was chaired by Shri Jishnu Barua, Chief Secretary to the Govt. of Assam.

The meeting was convened in the context of the continuing surge of infections in the second wave of COVID-19 pandemic and to discuss on the best possible measures to be undertaken to curb the spread of the virus across the State.

After detailed discussion, it was decided to issue revised and consolidated directives in supersession of earlier orders incorporating the following clauses :

- 1. All shops, commercial establishments and offices both private and Government should be shut down at 2 PM (1400 Hrs) on all days;
- 2. No meeting / gathering at any open or closed spaces should be allowed;
- 3. For marriages, only religious part will be allowed with presence of maximum of 20 (twenty) persons. No receptions will be allowed;
- 4. At all religious places, congregation of more than five persons shall be allowed at any time;
- 5. Total restrictions on movement of persons at public places shall be imposed from 6 PM (1800 Hrs) to 5 AM (0500 Hrs) on all days. District Magistrates and Commissioner of Police, Guwahati will issue orders under Cr PC to the same effect. However, the following categories will be exempted from the total restrictions
 - a) All essential and emergency works and personnel involved in the same will be included in the exempted category subject to certification from the head of the organization;
 - b) Continuous process industries are exempted from the purview of this order;
 - c) Journalist engaged in collecting news from the field and dissemination of the same are exempted from the purview of this order;
 - d) Members of Police, Armed Forces and Disaster Response Forces are also exempted from the purview of this order;
 - e) Health care personnel, including animal health care professionals are exempted from this order.
 - f) Passengers travelling to and from Bus Stations, Railway Stations & Airport shall be allowed to proceed only on production of valid tickets / travel documents.

- 6. These restrictions are to be put into force from 5 AM of 5th May, 2021 and should remain in force until further order.
- 7. It was decided to hold a Video Conference with all Deputy Commissioners and Superintendents of Police and ask them to implement this revised order and Containment Zone instructions expeditiously.

The meeting ended with vote of thanks from the Chair.
