MINUTES OF THE 1st and 2nd QUARTER, 2019 MEETING OF THE "STATE SCHOOL SAFETY ADVISORY COMMITTEE (S-SSAC)" FOR MONITORING IMPLEMENTATION OF NSSP IN THE STATE HELD ON 21st August, 2019 AT 12:30 P.M. IN THE ASSAM STATE DISASTER MANAGEMENT AUTHORITY (ASDMA) CONFERENCE HALL.

- A. The 1st and 2nd Quarter meeting of the State-School Safety Advisory Committee was held under the Chairmanship of Smti. Madhurima Barua Sen, IAS, Secretary, Secondary Education. Shri. Fazlul Haque Chowdhury, ACS, Jt. Secretary, Secondary Education and Smti. Rita Gogoi, ACS Joint Secretary, Elementary Education was also present in the meeting. The meeting was convened by Smti. Meenakshi Das Nath, ACS, Jt. Secretary & State Project Co-ordinator, ASDMA.
- B. The stakeholders present in the meeting were from Health department, Directorates of Elementary & Secondary Education, RMSA, SCERT, Disaster Management, Fire & Emergency Services, UNICEF, Red Cross Society etc. List of stakeholders present in the meeting are at *ANNEXURE-A*. No representative from SSA, Assam attended the meeting.
- C. The Chairperson took detailed review on the action taken of Minutes of the 3rd & 4th State School Safety Advisory and Time Bound Action Plan in the meeting and expressed her concern on the strict implementation of the matter. The action taken on the minutes is at **ANNEXURE-B.** Chairperson directed to take decision on items pending action.
- D. ASDMA highlighted the issue of non-receipt of 2nd Quarter compliance report from the Education department. The other discussions and key resolutions taken during the meeting are as below-
 - 1. Representative from RMSA informed the members that MHRD, Govt. of India has allocated approx. 630 lakhs towards implementation of School Safety in Assam. In order to avoid duplicity of efforts, Chairperson directed SSA/RMSA to submit details of budget allocated by MHRD, Govt. of India along with Action Plan for implementation of School Safety in Assam.
 - Secondary Education department will direct SSA/ RMSA to ensure strict compliance on NSSP matters and for adherence to decisions pertaining to SSA/RMSA taken in State School Safety Advisory Committee (S-SSAC).
 - 3. Secondary Education Department will enquire with SSA/RMSA about space available in Mid-day meal calendar for publishing Disaster Management related information and budget requirement, if any.
 - 4. Non-compliance of any stakeholder to the directions of State School Safety Advisory Committee (S-SSAC) will be brought to the notice of Hon'ble' Chief Minister of Assam. The decision was taken due to poor representation of members of SSA in School Safety related matters.
 - 5. Smti. Rita Gogoi, Joint Secretary to the Govt. of Assam, Elementary Education was directed to liaise with Finance department regarding status of "Assam Comprehensive School Safety & Security Guidelines"
 - 6. Chairperson directed ASDMA to submit materials to the MD, Assam State Textbook Production and Publication Corporation, SEBA & AHSEC for printing of safety information in cover page of Textbooks (preferably in the inner page of back cover). Representatives from SCERT informed that contents should be submitted to SEBA /AHSEC within 10th September, 2019.
 - 7. Chairperson directed Directorate of Elementary and Secondary Education to submit proposal to SSA /RMSA along with guidelines for procurement of "School Disaster Management Kit"

- 8. ASDMA will provide training to the District Project Engineers and Junior Engineers (SSA/RMSA) on structural safety matters of schools. Education department (SSA) will nominate Engineers for the training.
- 9. One refresher training on "NSSP Quarterly Compliance report" will be conducted next year by ASDMA for the District Nodal Officers, NSSP in collaboration with the Education Department.
- 10. Representative from UNICEF, Assam highlighted the initiatives taken during Flood, 2019 through a power point presentation on the Pilot initiative of developing Child Friendly Spaces in Emergencies (CFSiE) in Assam. UNICEF informed that the road ahead for CFSiE would be a lessons learnt workshop, notification of a detailed guideline, integration of CFSiE in routine training programmes of ASHA, AWW, Teachers etc., development of District level SOPs, Pre-notification of CFS wise deputation by respective line department, making CFSiE mandatory for all designated relief camps, Standardization of CFSiE Curriculum, alternative arrangements (design, materials and resources) for displaced children taking shelter elsewhere (other than relief camps)etc.
- 11. Joint Secretary to the Govt. of Assam, Secondary Education Department requested UNICEF to ensure inclusion of special provisions for Children with Disability in the CFSiE guideline.
- 12. ASDMA developed a Guideline for District School Safety Advisory Committees (DSSAC) and shared the same with all members during the meeting. Chairperson suggested that the draft guideline should be shared with all NSSP stakeholders for inputs or comments. Draft guideline is at **ANNEXURE-C.**
- 13. State Fire & Emergency Services submitted list of **916 schools** in which Fire safety audit and mock drills were conducted from April, 2018 to March, 2019. However ASDMA requested F&ES to submit findings of the safety audit and actions suggested for the schools based on findings of audit.

The meeting ended with a Vote of Thanks from the chair.

Guidelines to District School Safety Advisory Committees (D-SSAC):

- Ensure quarterly meetings are held with all stakeholders including Block-School Safety
 Advisory Committees to review the school safety across District. Minutes of Quarterly
 meetings should be sent to the SDMA along with action taken on minutes of previous
 quarter.
- 2. Develop a "District Wide School Safety Plan" as well as plans for each school in the system. Accordingly direct BSSAC to take necessary action as below:
 - A. Direct the BSSAC to monitor preparation of "School Disaster Management Plan (SDMP)" in all schools under the Block in a phase wise manner. The School Focal Point Teacher (SFPT) which receive training on SDMP preparation will immediately prepare "SDMP" for his own school and submit to Block for verification
 - B. Block—SSAC will visit schools which prepared SDMP and suggest if any modifications required in SDMP. Members of Fire Safety team will conduct safety audit during the visit and submit report to D-SSAC for corrective measures if required. SSA/RMSA Engineers or any other Engineer trained on RVS/Structural safety will inspect the School Building and submit report to D-SSAC
 - C. Block will review SDMP of at least 12 schools in each quarter and submit report to D-SSAC for review and approval. D-SSAC will issue instruction to initiate action on corrective measures immediately for each quarter
- 3. DSSAC will direct Headmaster or Principal of the school to take immediate corrective measure suggested by F&ES & Engineer
- 4. Chairman D-SSAC will explore funds from corporate bodies under CSR/ MP-LAD fund or any fund from external donor agencies to develop/ make a school resilient enough to disasters. Vulnerable school infrastructures will be given utmost priority in this selection. Before taking any structural intervention, DSSAC will send details of proposal to the S-SSAC for review/comments. D-SSAC may appoint a panel of technical agencies involving certified or trained Structural Engineers/Engineering consultants etc. to advice on resilient designs for school buildings.
- 5. Headmaster will submit report to B-SSAC on corrective measures taken on recommendations of inspection team. And B-SSAC will submit report to D-SSAC.
- 6. Chairman, D-SSAC will be responsible for reviewing the "Quarterly Compliance Report" to be submitted to NDMA. Inspector of Schools & District Elementary Education Officer (District Nodal Officer, NSSP) will justify all the data/figures submitted in the format and Chairman, D-SSAC will verify the figures so as to ensure that erroneous data is not submitted to the State.
- 7. The DSSAC resolutions along with "Quarterly Compliance Report" for each quarter should be submitted to the State Headquarter 10 days ahead of each quarter ending.
- 8. DPO, DDMA will be responsible for timely submission of Minutes of Meeting and related information to the State HQ.
- D-SSAC shall be responsible for compliance of all instructions issued by the State School. Safety Advisory Committee (S-SSAC) from time to time.



10. D-SSAC will review the "Child Death Quarterly Reporting Format" and submit the signed format at the end of each quarter

Additionally DSSAC will ensure the following:

- 1. District-level baseline of schools to be made safer. These can be assessed through "Rapid Visual Screening' or any other tool to cover all hazards relevant to the area.
- 2. Proximity of emergency and crisis service agencies, their capabilities and consequently their expected response time;
- 3. Physical infrastructure and facilities to resist known hazards that are relevant to capacity of school
- 4. Information related to the existing resources and capacities in the school and the community with regard to disaster management;
- 5. Information related to hazards and risks posed by other facilities in the vicinity of the school e.g. any industrial establishments producing hazardous materials.
