Tenders received without the requisite fee shall be considered as invalid ab-initio.

1.1 ELIGIBILITY CRITERIA

1. The Average Annual Financial Turnover of the bidder during the last 3 years, ending 31st March 2015, should be Rs 50 Lakhs.
(Please submit Annual Report (Balance Sheet and Profit & Loss Account) for the last three financial years).
2. The Bidder should not have been barred by any PSU/Govt. Dept. in doing business with them. (Please submit self-declaration).
3. The Bidder should be Original Equipment Manufacturer (OEM) of the Tendered item/or authorized dealer of the OEM.
4. Successful Bidder will be required to have VAT Registration in Assam/CST (as applicable).
5. Experience of having successfully delivered minimum 50 Inflatable Rubber
