- 7. To design and conduct capacity-building programs related to design of concept notes, proposals and budgets towards accessing different financial windows for DRR Roadmap interventions.
- 8. To support designing of flagship programs/schemes with stakeholder departments across various priorities of DRR Roadmap.
- 9. To develop case studies, document success stories as well as stories of unsuccessful interventions.
- 10. To support Secretarial functions towards organizing conventions of the state platform for DRR.
- 11. To assist stakeholders in developing proposals to access financial resources applying for various funding windows in accordance with need, scope and adherence to guidelines applicable to specific funding window.
- 12. To execute overall M&E functions as outlined in the DRR Roadmap document.
